California Budget Crisis:

Senate Budget Subcommittee Health & Human Services Hearing Today – Updated Schedule of Final Round of Subcommittee Hearings As Budget Process Moves to Next Phase

SACRAMENTO, CALIF (CDCAN) [Updated 05/21/2010 06:10 AM (Pacific Time)] - The Senate Budget Subcommittee #3 on Health and Human Services will meet this morning (May 21) at 09:30 AM in the State Capitol in Room 4203, and focus on the Governor's budget revisions released May 14th that impact developmental services, certain issues under the Department of Public Health including those dealing with AIDS programs, two issues under the Department of Health Care Services including family health and 3 "for vote only" issues dealing with mental health (but not the proposed suspension of the AB 3632 special education mandate or the proposed reduction of 60% of the funding for county mental health services).

Given the volume of emails, comments or inquiries by email generally are not useful unless a person knows the staff person or the legislator.

Regional Centers Budget Issues on Agenda Today

- The Senate hearing today in the developmental services section (under the Department of Developmental Services) will look at several issues impacting the 21 non-profit regional centers who coordinate community-based services for over 240,000 children and adults with developmental disabilities, and also early intervention services for thousands of babies and toddlers with developmental delays.
- One of those issues is the Governor's proposal, made originally in January, that called for an additional reduction of about \$50 million (about \$25 million in State general funds) though at that time in January no details on how that cut would be achieved was released.

- Details however were released in late April in advance of the May 14th budget revisions by the Governor, that called for an additional 1.25% reduction in payments to most regional center providers and regional operations (to go into effect July 1, 2010 through June 30, 2011) on top of the existing 3% reduction.
- To help those providers deal with the impact of the additional proposed payment reduction, the Governor proposed temporarily suspending some reporting and other requirements for regional center providers impacted by this reduction.
- The Senate budget subcommittee staff is recommending that this item be held “open” until next week.
- The Department of Developmental Services – the state agency that oversees the regional center community-based services, and the operations of the state owned and staffed developmental centers and 1 smaller facility – released this week proposed budget legislative language (referred to as “budget trailer bill language” because the language will eventually be put into a bill that will follow or trail the main budget bill).

Some Transition Issues Impacting Lanterman Developmental Center Proposed Closure on Agenda

- Also on the agenda today are several transition related issues impacting the proposed closure of Lanterman Developmental Center that the Governor included in his May 14th budget revisions. This included adjusting the numbers of people that the Department of Developmental Services assumes would be transitioned from the center during the 2010-2011 State Budget year, from 37 to 100 (assuming final approval of the proposed closure plan). The transitions of those persons would be based on their individual program plan under the Lanterman Developmental Disabilities Services Act – California’s civil rights act for people with developmental disabilities. No other state in the nation has such a law.
- It does not appear that final action on the actual closure plan itself – which was heard by this subcommittee with public testimony on April 29th – will be taken up at today’s hearing. All indications in both the Assembly and Senate subcommittees however indicate that both will likely approve the plan – which the Department of Developmental Services released April 1st, in their final hearings next week.
- No action by the subcommittees are final however until the Legislature passes – and the Governor approves – the actual main budget bill and the package of budget related bills. That passage and approval is expected to be delayed through the summer due to what many anticipate will be a long budget stand-off.
